## Fire Academy Application

### INTRODUCTION

The Spring 2025 Oxnard College Fire Academy begins on **January 6, 2025**. Classes are held Monday thru Thursday beginning at 0615 and ending at 1720. This is an 18-week class that graduates on May 9.

### PREREQUISITES

Successful completion of the classes below is required prior to Fire Academy start date. Students who have completed all prerequisites at time of application are given first consideration.

- **FT R151, FT R154, or equivalent** - Successful completion (C or better).
- **EMT R169 - Emergency Medical Technician** - *A copy of the "Course Completion Record" must be submitted as proof of successful skills exam completion OR a copy of your EMT certification card through the state of California or NREMT. The "Course Completion Record" or EMT card must be valid through the application process up to the completion of the academy.*

### PHYSICAL REQUIREMENT

- **Fitness:** At orientation, prospective cadets will need to complete 5 towers runs in 9 minutes to demonstrate the minimum physical fitness standard. Failure to demonstrate this minimum level of fitness will result in dismissal from the program.
- **Health:** Students will be required to pass a health, wellness, stamina, and strength screening which will be conducted by the college at a designated time and location. Details will be required at orientation.

### SELECTION PROCESS

All support documents must be in your application package for you to be considered for the Academy. Any course in progress will need to include a Progress Report with current grade from your instructor. Incomplete applications will be set aside and ranked last.
